1) Afghanistan embassy in New Delhi

BANKING NEWS

1) Bandhan Bank

- The board of directors at Bandhan Bank has given the green light for the reappointment of Chandra Shekhar Ghosh as the Managing Director & Chief Executive Officer (MD&CEO).
- The Kolkata-based private sector lender has extended Ghosh's tenure for a period of three years. The current term is set to expire on July 09, 2024.

2) Reserve Bank of India

- The Reserve Bank of India (RBI) announced on Friday that it has superseded the board of Abhyudaya Cooperative Bank for a duration of 12 months.
- This action comes as a response to certain material concerns arising from observed poor governance standards within the bank.

3) Reserve Bank of India

- The Reserve Bank of India, on 24 November, took stringent measures against Citibank, Bank of Baroda, and Indian Overseas Bank, imposing penalties totaling ₹10.34 crore.
- The penalties were imposed for contravention of regulatory norms, shedding light on deficiencies in regulatory compliance.

BUSINESS AND ECONOMY

1) Warren Buffett-led Berkshire Hathaway

- Warren Buffett-led Berkshire Hathaway has made headlines by completely divesting its 2.46% stake in One 97 Communications, the parent company of Paytm.
- The move resulted in a significant loss of about Rs 507 crore for the legendary investor.

2) Svatantra Microfin Private Limited

- Svatantra Microfin Private Limited, founded by Ananya Birla, is set to acquire Chaitanya India Fin Credit Private Limited, a subsidiary of Sachin Bansal's Navi Group, in a significant deal valued at Rs 1,479 crore.
- The transaction is anticipated to be finalized by the end of 2023.

3) Reserve Bank of India

- The Indian rupee closed at a new low of 83.38 against the US dollar, marking a slight decline from the previous close of 83.34.
- This drop was attributed to increased dollar demand from oil companies and intervention by the Reserve Bank of India (RBI) to mitigate a steeper fall.
